KEYNOTE SPEAKERS



Kristina M. Johnson

Kristina M. Johnson, PhD, joined The State University of New York as its 13th chancellor in September 2017. Immediately prior to joining SUNY, Dr. Johnson was co-founder and CEO of Cube Hydro Partners, LLC, a clean-energy infrastructure company focused on building and operating hydropower plants in North America. She also previously served as Under Secretary of Energy at the U.S. Department of Energy.

Johnson served as provost and senior vice president for Academic Affairs at Johns Hopkins University from 2007 to 2009, and as dean of the Pratt School of Engineering at Duke University from 1999 to 2007.

She received her BS, MS, and PhD in electrical engineering from Stanford University. After a NATO postdoctoral fellowship at Trinity College in Dublin, Ireland, she joined the University of Colorado-Boulder's faculty in 1985 as an assistant professor and, later, full professor.

Among her many awards and distinctions, Johnson received the Dennis Gabor Prize for creativity and innovation in modern optics (1993) and the John Fritz Medal (2008), widely considered the highest award in engineering. Johnson is a member of the National Academy of Engineering, the National Academy of Inventors, and the National Inventors Hall of Fame. She holds 118 U.S. and international patents and has five honorary degrees.



Robin W. Kimmerer

Robin Kimmerer, PhD, is a mother, plant ecologist, writer, and SUNY Distinguished Teaching Professor at the SUNY College of Environmental Science and Forestry (ESF) in Syracuse, N.Y. She serves as the founding director of the Center for Native Peoples and the Environment. Her research interests include the role of traditional ecological knowledge in ecological restoration and the ecology of mosses.

She is the co-founder and past president of the Traditional Ecological Knowledge section of the Ecological Society of America, and serves as a senior fellow for the Center for Nature and Humans.

As a writer and a scientist, her interests in restoration include not only restoration of ecological communities, but restoration of our relationships to land. Her essays appear in *Whole Terrain, Adirondack Life, Orion,* and several anthologies. Her latest book, *Braiding Sweetgrass: Indigenous Wisdom, Scientific Knowledge and the Teachings of Plants,* was released in 2013 and was awarded the Sigurd Olson Nature Writing Award.

Kimmerer holds a BS in botany from SUNY ESF, an MS and PhD in botany from the University of Wisconsin, and is the author of numerous scientific papers on plant ecology, bryophyte ecology, traditional knowledge, and restoration ecology. Of European and Anishinaabe ancestry, Kimmerer is an enrolled member of the Citizen Potawatomi Nation.

Marian Brown MODERATOR

Marian Brown is the director of the Center for Sustainability and the Environment at Wells College, a position she has held since 2014. Prior to joining Wells, she served in a similar sustainability leadership role at Ithaca College for many years. Brown earned a Bachelor of Science in Biology and secondary school teaching certification from SUNY Brockport and went on to earn a Master of Science in what was then called Corporate Communications while working full time at Ithaca College.



Jonathan Gibralter

Jonathan Gibralter assumed the presidency of Wells College in July 2015. Gibralter's leadership is marked by a deep understanding of the current climate of higher education and the undergraduate experience, a demonstrated commitment to student well-being and environmental sustainability, the creativity and courage to pursue innovative solutions, and financial acumen.

Gibralter is a nationally recognized thought leader on issues of sustainability and is sought out by the media as an effective leader on these efforts. He also is a frequent contributor to professional journals and conferences, and has provided expert testimony for the U.S. Department of Education and Congress.



Mark Lichtenstein

Mark Lichtenstein is chief of staff and chief sustainability officer at the State University of New York College of Environmental Science and Forestry (ESF). He is an environmental studies adjunct faculty member at ESF and a faculty associate in the Program for the Advancement of Research on Conflict and Collaboration at Syracuse University's Maxwell School. Lichtenstein led sustainability centers at Syracuse University and served as an expert witness to the federal Environmental Finance Advisory Board. He served eight terms as president, and is an honorary lifetime board member of the National Recycling Coalition. Lichtenstein also led and developed a regional solid waste management and recycling program in upstate New York. Most recently, he has focused efforts on disaster response in Mexico, Puerto Rico, the Southeast United States, and the United States Virgin Islands. He is a member of SUNY Chancellor Kristina Johnson's Puerto Rico Task Force. He is a co-founder of the Puerto Rico and United States Virgin Islands Recycling Partnerships.

Lichtenstein has a Master of Arts in Public Administration and a Graduate Certificate of Advanced Studies in Conflict Resolution from the Maxwell School, and a Bachelor of Science in Environmental Studies from ESF.



Trish St. Leger

Trish St. Leger came to Colgate in 1998, having worked 14 years in both technology and finance positions in the private sector, including Xerox Corporation, General Electric Company, and Lockheed Martin Corporation. As vice provost for administration and planning, St. Leger's primary responsibilities are to provide strategic leadership and day-to-day oversight of the business operations for the academic enterprise, specifically in the areas of budget and financial planning, facility planning and capital projects, human resources and compensation, and policy development. Her portfolio of duties over her time at Colgate has included serving as director of Colgate's LLCs, interim chief information officer, Title IX coordinator, and staff affirmative action officer. In 2009, she began supervising the office of sustainability. St. Leger earned her BA from SUNY Oswego and MBA from the Simon Graduate School of Business, University of Rochester.



Marion Terenzio

Marion Terenzio, PhD, who is the 12th president of State University of New York College of Agriculture and Technology at Cobleskill, has received numerous awards and recognition for her work as a shared governance leader in creating a relevant and thriving campus community and for revitalizing higher education's role as a vital partner in sustaining engaged and healthy surrounding communities. Terenzio has published and presented at numerous venues, including the United Nations, on the role of effective higher education practices in community well-being and economic revitalization and sustainability.


